From North Atlanta: Take I-85 North to Hwy 316 East. Follow Hwy 316 to Hwy 81. Turn right onto Hwy 81 and go approximately 5 miles to the second four-way stop. Turn left at stop sign onto Bold Springs Road. Proceed about 2 miles and The Providence Club will be on the left.

From South Atlanta: Take I-20 East to Hwy 138 North, Exit 42 in Conyers. Take 138 North, past Woodlake to Hwy 78. Take Hwy 78 East one exit to Hwy 11. Turn left onto Hwy 11 (North), then turn left on Bold Springs Rd. Proceed 6.1 miles and The Providence Club will be on the left.
