**DIRECTIONS:**

From North Atlanta/Athens: Take Hwy. 78 towards Monroe. Exit at the Conyers/Hwy 138 exit (the exit will automatically put you on 138 south). Continue south on 138 for 3-4 miles and course is on the right.\*\*\* **SHORTCUT**\*\*\*- If coming east on Hwy78 from Atlanta. Go 5-6 miles past Loganville into the small town of Between. Just past Between you will see a large water tower (Walton County Water Auth.). At the water tower take a right (Youth/ Monroe Rd.). You will then take an immediate left (H.D. Atha Rd.). Go approx. 1 mile to Woodlake subdivision on the right. Follow signs to the course.

From South Atlanta: Take I-20 East to Conyers/Hwy 138 exit. Turn left (North) and go 15.3 miles and the course is on the left.
